# GENERAL INFORMATION

**Conference Registration**—Please complete the enclosed Conference Registration Form and return it, along with the appropriate fees, **no later than October 21, 1988**. All fees paid, less \$10.00, are refundable if the registration is cancelled before November 1, 1988. The Basic Registration Fee includes: Monday's President's Reception; Tuesday's Creative Awards Luncheon; Wednesday's Regional Breakfast, Conference Reception, and Conference Banquet; and Thursday's Breakfast Buffet. Additional tickets for spouses/guests are available for all non-meeting functions. The fees for these activities are indicated on the Conference Registration Form.

**Multiple Institutional Registrations**—A reduced Registration Fee is available to any institution bringing more than two people to the conference. After the first two attendees pay the \$130.00 (for NAASS members) or \$175.00 (for non-NAASS members) Basic Registration Fee, all additional registrants from that institution will pay \$100.00. Please submit all registrations at the same time to ensure proper credit.

**Hotel Reservations**—A reservation card and return envelope have been provided in this packet. Single or double rooms are at the rate of \$64.00 per night. To confirm your reservation, return the enclosed reservation card or call 1-800-648-1177 **no later than October 13, 1988**. Reservation requests received after that date will be confirmed subject to room availability only.

**Ground Transportation and Parking**—Reno Cannon International Airport is only five minutes away from John Ascuaga's Nugget Hotel. The hotel's shuttle van leaves the airport every half hour. Limousine service to the Nugget is also available at \$2.25 per person. Check at the counter adjacent to the baggage claim area. If you plan to drive, there is plenty of free parking in the lots surrounding the Nugget. Valet parking is offered at the hotel lobby entrance.

**Weather**—Reno lies at the foot of the Sierra Nevada on the Great Basin Desert's western edge. Located at 4,400 feet altitude, the resort area typically enjoys warm to cool days and cold evenings in the fall. Average mean temperatures are 55 degrees for the daytime and 23 degrees at night. The high altitude, coupled with low humidity, make both low and high temperatures quite bearable. No matter what the season, your chances of sunshine are 80 percent. Snow is possible, but not likely, at this time of year.

**The Area**—Visitors will find an ambience that blends big city sophistication with the relaxed beauty of a vacation resort. Casual dress is the accepted daytime fashion. If you plan to take in the area's famed nightlife, casual clothes are fine, but gentlemen should plan to wear jackets, with ties optional, at most dinner shows.

In your free time, you may want to visit Harrah's Automobile Collection, featuring the world's finest car museum, or the planetarium located on the University of Nevada-Reno campus—both just minutes from the hotel by car. If you extend your stay, you can choose from Lake Tahoe's spectacular beauty, Virginia City's oldtime charm, or Pyramid Lake's desert splendor—each less than 30 miles away.

**Restaurants**—The Reno area offers many fine places to dine in addition to the Nugget's own award-winning restaurants. Your registration packet will contain a restaurant guide to help you sample the local cuisine.

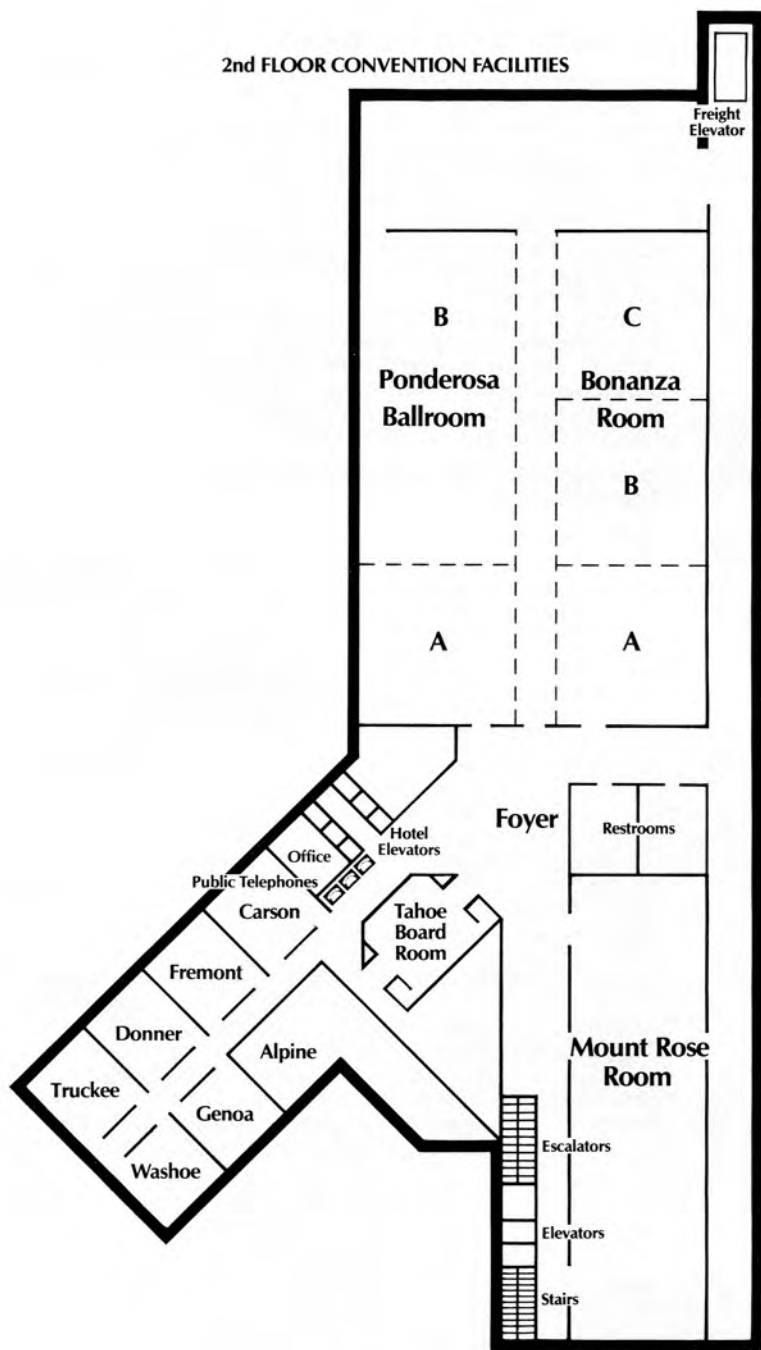

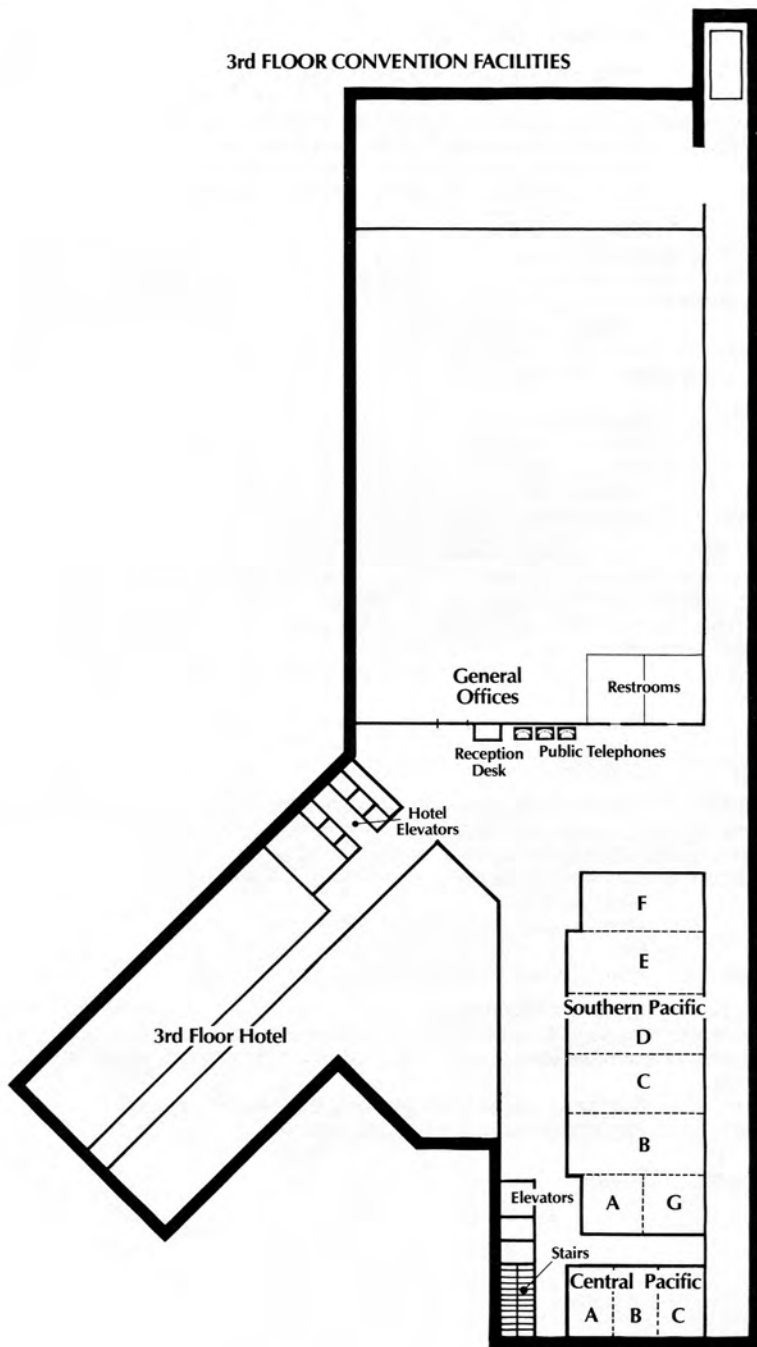
