

In the summer of 2016, Purdue piloted a scholarship program aimed at influencing the behavior of current students who had previously had the opportunity to stay on campus and take courses during the summer, but did not choose to do so. Known as Summer Stay Scholars, this scholarship program offers full coverage of tuition and fees for two-to-three on-campus summer courses, with the intention of changing their future summer behavior. In addition to taking classes, recipients of the scholarship were required to participate in an on-campus internship or research project, helping students to both stay on track or accelerate their progress towards degree completion and gain practical, hands-on experience with University faculty and staff mentors. In January of 2013, Georgia Tech's provost appointed a Summer Semester Working Group (SSWG) to develop recommendations regarding the management, approach and revenue allocation for a summer semester. Within its charge, the SSWG was asked to envision broadly what a summer session should be at Georgia Tech. As part of its research, the working commissioned a market research study. In this session, the presenters will share the methodology and findings of this study, and discuss its implications for developing a comprehensive summer session initiative.

Prior to each term, students must select courses to satisfy degree requirements and make progress towards graduation. Course selection is a predominantly sequential process - some courses must be taken before others, others at the same time, all for some specific curricular purpose. But is there more to it? Given some flexibility in their programmatic decision-making, will students choose one course over another if its mere title is somehow more appealing? Is there a subset of semantic secrets that might sway our students' selections?
